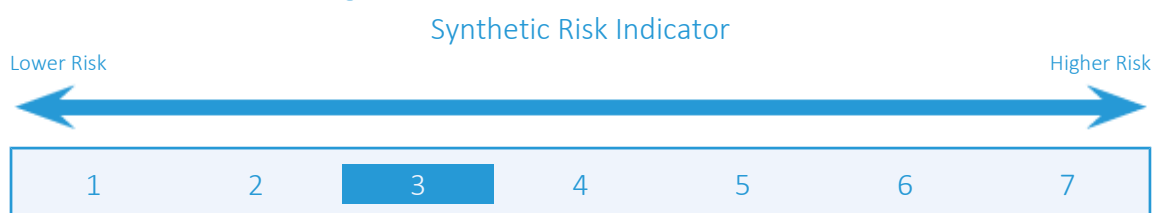

## What is this product?

- **Type:** The product is a Sub-Fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a Undertakings for Collective Investment in Transferable Securities (UCITS) pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:**
  - The Sub-Fund's objective is to achieve, over the long term, a return on your investment in the form of capital growth and income by investing in global fixed income securities (e.g., government and corporate bonds) listed on Recognised Exchanges, including non-investment grade securities and exposures to emerging markets.
  - The Sub-Fund will seek to achieve its investment objective by primarily investing in Sustainable Investments (Sustainable Investments are investments in companies which, in the Manager's opinion, contribute to an environmental or social objective (provided that such investments do not significantly harm any of those objectives and that the invested companies follow good governance practices). The Sub-Fund will primarily invest in sustainable bonds (e.g., bonds labelled green, social and sustainable) or securities with direct exposure to corporate or sovereign bonds that are considered to be Sustainable Investments, in the Manager's opinion or appointed third-party manager(s)' opinion.
  - The Sub-Fund may use Financial Derivative Instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management purposes, hedging and liquidity management and Investment purposes.
  - Financial Derivative Instruments (FDIs) are used to remove the impact of exchange rate movement (hedging) which may affect the value of this Class of Unit.
  - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
  - The Manager has flexibility to change the Sub-Fund's asset allocation at any time and has discretion to select investments within each asset class.
  - The Sub-Fund is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
  - Income and gains generated by the unit class will be distributed periodically in the form of a dividend.
  - Units can be bought or sold on any business day from the Fund's Administrator. Please refer to the Prospectus and Sub-Fund Information Cards, in the sections titled 'Investment Objectives and Policies' for more detailed information.

## What are the risks and what could I get in return?



**The risk indicator assumes you keep the product for 5 years.**

- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the

- We have classified this product as 3 out of 7, which is a medium-low risk class.

### What happens if Mediolanum International Funds Limited is unable to pay out?

The assets of the Fund are held in safekeeping by its depository. In the event of the Manager's insolvency, the Fund's assets in the safekeeping of the Depository will not be affected. However, in the event of the Depository's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. In such a scenario, there is no investor guarantee scheme and you could lose all of your investment.

### What are the costs?

#### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. The amounts shown here are illustrations based on an example investment amount and different investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

The recommended holding period (RHP) has been calculated in line with the investment strategy of the Sub-Fund and the timeframe in which it is expected that it will be possible to achieve the investment objective of the Sub-Fund. The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied. We recommend that you hold the investment at least until the end of the recommended holding period in order to fulfil the objectives of this product. This product may not be suitable for investors who plan to redeem their contract before the end of the recommended holding period. The product does not provide any guarantee of return on the expiration of the recommended time horizon, and any redemption before that date may compromise the investment performance. Please refer to the Prospectus for further details.
