## What is this product?

- **Type:** The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:** This is an open ended fund with no maturity date.
- **Objectives:**
  - The Sub-Fund's objective is to achieve long term capital growth.
  - The Sub-Fund invests primarily in Indian equities (listed shares) and equity related securities either directly or indirectly (by investing in funds).
  - The Sub-Fund offers investors exposure to a diversified portfolio of Indian equities (company shares). These may include corporations with offices registered in India, corporations that exercise a preponderant part of their economic activity in India and corporations whose equity and equity related securities are listed, traded or dealt on Indian Recognised Exchanges.
  - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct investment purposes.
  - The Sub-Fund may enter into securities lending transactions.
  - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
  - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/FDIs etc) at any time and has discretion to select investments within each asset class.
  - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
  - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
  - Units can be bought or sold on any business day from the Fund's Administrator.

## What are the risks and what could I get in return?



**The risk indicator assumes you keep the product for 10 years.**

- We have classified this product as 4 out of 7, which is a medium risk class.

### Costs over Time

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## How long should I hold it and can I take money out early?

**Recommended holding period: 10 years**

The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied.
