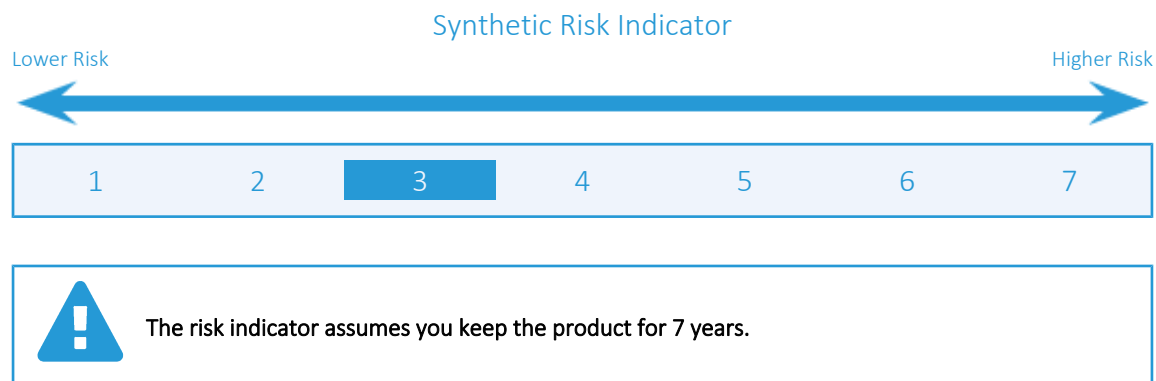

## What is this product?

- **Type:** The product is a Sub-fund of Mediolanum Best Brands (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- **Term:** This is an open ended fund with no maturity date.
- **Objectives:**
  - The Sub-Fund's objective is to pay regular dividends and achieve long term capital growth.
  - The Sub-Fund invests in global (including emerging market) equities (listed shares), equity related securities and fixed income securities (such as bonds issued by companies or governments) either directly and/or indirectly (by investing in funds and/or derivatives).
  - The Sub-Fund invests in funds which are selected following Manager evaluation of: investment team strength, underlying investment process quality, opportunity for future capital growth and ability to pay dividends.
  - The fixed income securities invested in may be rated investment grade (by a generally recognised international rating agency), below investment grade or unrated.
  - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
  - The Sub-Fund may enter into securities lending transactions.
  - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
  - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in equities/bonds/FDIs etc) at any time and has discretion to select investments within each asset class.
  - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
  - FDIs are used to remove the impact of exchange rate movement (hedging) which may affect the value of this Class of Unit.
  - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
  - Units can be bought or sold on any business day from the Fund's Administrator.

## What are the risks and what could I get in return?



- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 3 out of 7, which is a medium-low risk class.
- This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to

#### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. - In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## How long should I hold it and can I take money out early?

### Recommended holding period: 7 years

The recommended holding period for this Sub-Fund is determined based on the risk of the investment and the characteristics of the contract. The investor has the right to totally or partially redeem the contract on any valuation day, collecting the redemption value calculated based on the value of the shares of the Sub-Fund on the date the request is received by the Manager, without any redemption fee being applied.
