Mediolanum International Funds Limited (part of the Mediolanum Banking Group) is the Manager of the Fund.

## Objectives and Investment Policy

- The Sub-Fund’s objective is to achieve medium long term capital growth.
- The Sub-Fund invests primarily in global (including emerging market) equities (listed shares) and equity related securities either directly or indirectly (by investing in funds).
- The Sub Fund uses a long/short strategy which seeks to generate returns by combining long positions in undervalued securities, which could gain in value in rising markets, and short positions (indirectly via FDIs) in overvalued securities which could generate returns in falling markets.
- The Sub-Fund invests in funds which are selected following Investment Manager evaluation of: investment team strength, underlying investment process quality and opportunity for future capital growth.
- The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es).
- The Investment Manager has flexibility to change the Sub-Fund’s asset allocation (% of the portfolio invested in equities/ FDIs etc) at any time and has discretion to select investments within each asset class.
- The Sub-Fund is appropriate for investors with a medium-long term investment horizon.
- All income and gains generated by the LA Class and SA Class of Units will be reinvested. No dividends will be paid.
- Units can be bought or sold on any business day from the Fund’s Administrator.

## Risk and Reward Profile



- The risk category is based on historical data and may not be a reliable indication for the future.

- The Sub-Fund is classified in the risk category above due to the nature of its investments. The risk level is measured by the volatility of the Sub-Fund's past returns (or from the past returns of a suitable model portfolio if a full 5 year history is unavailable).

**The following risks are considered material and may not be fully captured by the risk and reward indicator:**

- Financial Derivative Risk - FDI values may rise and fall at a greater rate than underlying securities or instruments. Some derivatives may result in gains or losses that are greater than the original amount invested.
- Counterparty Risk - The risk that a counterparty will not fulfil their contractual obligations resulting in a potential loss to the Sub-Fund.
- Emerging Market Risk -Emerging Market economies may exhibit higher levels of investment risk than developed economies.

## Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry charge shown is a maximum figure. In some cases you might pay less.

As the Fund has not had a full year of performance, the ongoing charges figure is an estimated figure.

This figure may vary from year to year. It excludes:

- Performance Fees
- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Sub-Fund when buying or selling units in another fund.

The maximum Switch Fee payable for each switch is half the Entry Fee applicable to the new unit.
