Challenge Liquidity Euro Fund (the “Sub-Fund”) is a Sub-Fund of Challenge Funds (the “Fund”) Mediolanum Liquidity Euro L Class A Units (“LA Class”) - ISIN: IE0004878637 Mediolanum Liquidity Euro S Class A Units (“SA Class”) - ISIN: IE0004400374

Mediolanum International Funds Limited (part of the Mediolanum Banking Group) is the Manager of the Fund.

Objectives and Investment Policy

- The Sub-Fund’s objective is to provide capital stability while limiting fluctuations in the amount originally invested.
- The Sub-Fund invests in global money market instruments (short term debt instruments) and fixed income securities (such as bonds issued by companies or governments) issued in the Euro currency.
- The fixed income securities invested in will be investment grade (Standard & Poor’s/Moody’s credit rating of BBB-/Baa3) or better.
- The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es).
- The Investment Manager has discretion in managing the investments of the Sub-Fund.
- The Sub-Fund is appropriate for investors with a short-medium term investment horizon.
- All income and gains generated by the LA Class and SA Class of Units will be reinvested. No dividends will be paid.
- Units can be bought or sold on any business day from the Fund’s Administrator.

Risk and Reward Profile



- The risk category is based on historical data and may not be a reliable indication for the future.

- The Sub-Fund is classified in the risk category above due to the nature of its investments. The risk level is measured by the volatility of the Sub-Fund's past returns (or from the past returns of a suitable model portfolio if a full 5 year history is unavailable).

The following risks are considered material and may not be fully captured by the risk and reward indicator:

- Credit Risk - The issuer of a fixed income security held within the Sub-Fund may not be able to meet its obligations, even partially, to the Sub-Fund. Downgrades of an issue or issuer credit rating may lead to a loss in the value of bonds.

Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry charge shown is a maximum figure. In some cases you might pay less.

The ongoing charges figure is based on expenses for the year ending 31 December 2016.

This figure may vary from year to year. It excludes:

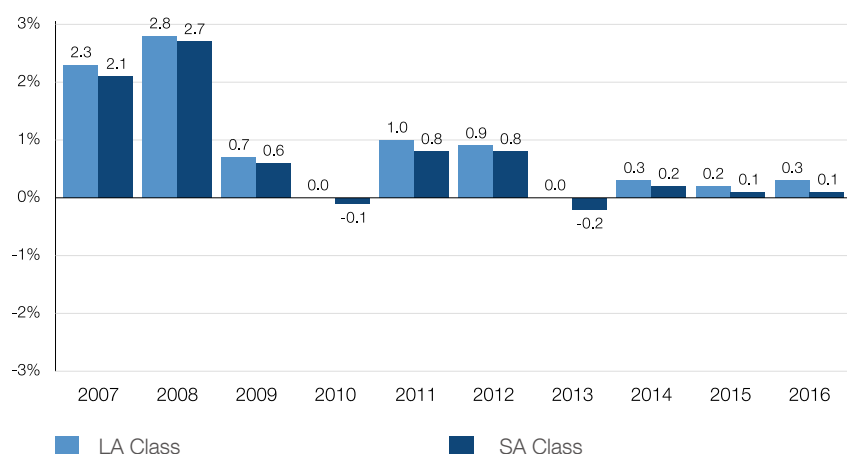
- Performance Fees
- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Sub-Fund when buying or selling units in another fund.

The maximum Switch Fee payable for each switch is half the Entry Fee applicable to the new unit.
